Jim Moore said he recalls meeting with the Wiedmeier's and their realtor Stuart Martin some time back. They were buying the home contingent upon the board approval for a future garage addition. Jim said he

would look in his records and report back next meeting. Also Jim and Tom agreed to make a site visit and hopefully talk with the Wiedmeir's to verify the project is in compliance of setback rules, etc.
