President Jim Moore then called the regular monthly CSSHOA Board of Directors Meeting to order following the Annual Meeting.

Drew Anderson read the minutes from the October 23<sup>rd</sup>, 2017 meeting. Tom made a motion to accept the minutes. Rich seconded and the motion carried.

Drew read the Treasurer's Report in Delia's absence. All homeowners have paid 2017 dues with one homeowner still owing part of 2016 dues. Tom moved to accept the Treasurer's Report. According to an email from Delia, the Consumer Price Index has increased approximately \$3.76 in the last 2 years. Sprinkler Service Company has not started work yet on the landscaping around the playground. Jim will call them and check when they think they can get started.

LTG Services and the board entered into a 2 year contract for mowing in 2017. Per the contract, the mowing rates will stay the same in 2018.

There were no pertinent Facebook updates this month. Drew is currently an administrator on the HOA Facebook page. Karen will add Jody as an admin to take his place with his possible move out of the neighborhood.

### New Business:

The board received a letter complaining about a large boat parked in a driveway. Jim walked the neighborhood and noticed 20 boats, trailers or campers parked in driveways that are a violation of the covenants. Karen will work on a form letter to be sent to the neighborhood reminding them that boats, trailers and campers are not supposed to be parked in driveways.

#### **Architectural Control Committee:**

There were no requests of the ACC this month.

Tom moved to adjourn the meeting at 7:56 PM. Rich seconded and the motion carried.
